PUBLIC COMMENTS

Paul T. Miura raised concerns about re-opening of schools. To consider teachers needing to arrange for day care for their kids. Vince Dela Cruz shared that most of his teachers are quarantined; it is difficult to go back to face to face. Phyllisiana Reyes asked for consideration in making remote learning in conjunction with those who want to go face-to-face. Remote learning was not an option and students were marked unexcused absent. Suaad San Nicolas shared that as a teacher, she cannot do face-to-face and Remote Learning. It is very difficult with IEP meetings and after-school teaching. Kayla Parsons shared that there is a good number of parents going for Remote Learning. Michelle Rasa stated that there is education being offered online for elementary and high school. Thalia Hofschneider is for remote learning to help reduce the spread of COVI and parents are able to help kids at home. Phyllis Ain shared that teachers are also having anxiety. Students Ginira Macaranas and Brinae Cruz also sent their comments via email to the Board.

Borja moved to approve the Re-Opening of Schools Face to Face on January 3, 2022 with Tinian and Rota schools to open on Monday, December 13, 2021 with the discretion of the Commissioner of Education.
